1.0 Relevant Background

The Defense Security Cooperation Agency (DSCA) has program responsibilities for sales and transfers of equipment and services (to include education and training) to international customers. This candidate must be able to provide advice and counsel to the Tri-Service Training community on administrative and policy/procedural issues for International Military Student (IMS) healthcare. In addition, this consultant must have significant in-depth knowledge and experience to work independently providing high level support throughout the DoD International Training infrastructure. This expertise is required to resolve both complex and routine day-to-day healthcare issues, perform "professor emeritus"/guest lecturer support services at several DoD training activities and provide policy oversight and advice to DSCA personnel focused on policy issues within OSD/Health Affairs.

2.0 Objective

The objective of this order is to secure qualified support for DSCA's IMS Healthcare requirements. The IMS Health Care Mission includes: providing guidance on the most recent legislation, regulations and policies concerning the health care of International Military and Civilian Students and their authorized accompanying family members; maintaining/updating as necessary, the Security Assistance Health Affairs Handbook; providing guidance for resolution of routine, unique, and unusual health care situations for the International Military & Civilian Students; assisting DoD (DSCA and OSD/Health Affairs), Military Departments, Unified Commands, Security Assistance Offices (SAOs), International Military Student Offices (IMSOs) and health care providers in health-related issues; attending/participating in annual Training Program Management Reviews (TPMRs), and supporting DSCA at same; and, providing consultation and health care briefs, as required.

3.0 Scope

4.0 Statement of Work

4.1 Act as DoD subject matter expert (SME) on the laws, regulations, instructions, and policies pertaining to health benefits for International Military Students (IMS) and their authorized accompanying family members. This includes but is not limited to:

- Providing the International training community the most recent legislative, regulatory and policy guidance concerning the healthcare of International Military and Civilian Students and their authorized accompanying family members.
- Providing guidance/advice/counsel for resolution of routine, unique, and unusual healthcare situations.
- Assisting DoD (DSCA and OSD/Health Affairs), Military Departments, Unified Commands, Security Assistance Officers (SAOs), International Military Student Officers (IMSOs) and health care providers in dealing with and resolving health-related issues.
- Providing consultation and healthcare briefings as required for/at DoD (DSCA and OSD/Health Affairs), Military Departments, (Unified) Combatant Commands, Security Assistance Offices (SAOs), and International Military Student Offices (IMSOs) to included IMS attending the Senior Service Schools.
- Performing analysis and formulating recommendations on policy related issues to OSD/Health Affairs, as required.
- Attending/participating in key meetings, i.e., TPMRs, while also providing subject matter expertise, as required.

4.2 Assist in maintaining the (International) Security Assistance Health (Care) Affairs Handbook, (web version & hard copy).

- Providing Information Technology support and advice to Defense Institute of Security Assistance Management (DISAM), maintaining the Health Affairs website and the on-line version of Security Assistance Health Affairs Handbook. Continually update the subject Handbook (on-line and hardcopy) as required to support the Security Assistance Training Program.
- Providing Handbook use and management briefings, as required, to DoD schools.
- Answering questions by telephone, email, or in person during meetings and visits to general Security Assistance Training community activities, i.e., SAOs, IMSO, HQ, field activities etc., as required.

4.3 Provide International Health Care briefings and subject matter expertise as follows:

- Attend regional Training Program Management Review (TPMR) conferences as directed to provide international health care briefings and expertise.
- Attend other conferences/meetings/courses as required, to include the International Military Student Officer (IMSO) Conferences, DISAM courses, and DSCA Policy meetings to provide international health care expertise.
- Attend DSCA meetings and Interagency Working Group (IAWG) meetings as required.

4.4 Support the DoD schools, as directed by the COR.

- Performing “professor emeritus”/guest lecturer support services at several DoD international training activities, i.e., DISAM, and International Military Student Offices (IMSOs).

5.0 Contract Management

5.1 Task Oversight. The COR will provide any required oversight.

5.2 Deliverables.

- Verbal or email status reports as required to cognizant COR.
- Monthly Report, if desired by the COR, addressing work assigned, accomplished and any issues emphasizing training processes and functional requirements.
- Soft copies of any reports, briefings, as required.

6.0 Level of Effort

It is estimated that approximately 1400 hours will be required in international program/project, technical and functional expertise during the contract year.

7.0 Performance

7.1 Place. The contractor shall perform activities at home and at applicable international training facilities supported (government site).

7.2 Period. One year with two optional years.

7.3 GFE/Data. GFE and supplies such as telephone and cell phone (both, local/long distance), computer and software for word processing and briefing preparations, standard office equipment and furniture as required, and normal office supplies such as paper, pens, etc.

8.0 Proprietary Information

The Government will retain rights to all intellectual property and modifications to software produced in the course of this project.

9.0 Travel

Local travel shall generally be performed between the contractor's facilities and the DSCA office in Arlington, VA. Long distance travel within the US and Overseas travel is anticipated and must be approved by the COR before the travel is made. (SEE CLIN 0006)

10.0 Payment Schedule

Monthly invoices will be allowed and will be paid within 30 days of receipt. Invoices will be submitted to COR for approval and certification prior to submitting to the corresponding DFAS office. The COR is responsible for submitting a DD 250 to certify all invoices.

2. Questions – The cut-off date for all questions is March 16, 2005 at 9:00 A.M. Eastern Daylight Time (EDT). No telephonic inquiries will be entertained.

1. Responses to all questions will be in the form of an amendment and electronically sent to prospective offerors.
2. All proposals shall be submitted as follows:
 - a. The contractor shall submit a written copy of the cost and technical proposal for consideration before the due date and time for this RFP. Proposals should be submitted no later than Friday March 25, 2005 at 10:00 A.M. EST.
 - b. Your proposal must demonstrate the rationale used to develop pricing. Items, which should be addressed, include: skill mix, number of hours per skill level, and Other Direct Costs. If Other Direct Costs are proposed, you must include a breakout of those costs. Offerors should break down cost for the base year and each option year respectively.

(b) Submission of offers. Submit signed and dated offers to the office specified in this solicitation at or before the exact time specified in this solicitation. Offers may be submitted on the SF 1449, letterhead stationery, or as otherwise specified in the solicitation. As a minimum, offers must show--

- (1) The solicitation number;
 - (2) The time specified in the solicitation for receipt of offers;
 - (3) The name, address, and telephone number of the offeror;
 - (4) A technical description of the items being offered in sufficient detail to evaluate compliance with the requirements in the solicitation. This may include product literature, or other documents, if necessary;
 - (5) Terms of any express warranty;
 - (6) Price and any discount terms;
 - (7) "Remit to" address, if different than mailing address;
 - (8) A completed copy of the representations and certifications at FAR 52.212-3 (see FAR 52.212-3(j) for those representations and certifications that the offeror shall complete electronically);
 - (9) Acknowledgment of Solicitation Amendments;
 - (10) Past performance information, when included as an evaluation factor, to include recent and relevant contracts for the same or similar items and other references (including contract numbers, points of contact with telephone numbers and other relevant information); and
 - (11) If the offer is not submitted on the SF 1449, include a statement specifying the extent of agreement with all terms, conditions, and provisions included in the solicitation. Offers that fail to furnish required representations or information, or reject the terms and conditions of the solicitation may be excluded from consideration.
- (c) Period for acceptance of offers. The offeror agrees to hold the prices in its offer firm for 30 calendar days from the date specified for receipt of offers, unless another time period is specified in an addendum to the solicitation.

(d) Product samples. When required by the solicitation, product samples shall be submitted at or prior to the time specified for receipt of offers. Unless otherwise specified in this solicitation, these samples shall be submitted at no expense to the Government, and returned at the sender's request and expense, unless they are destroyed during preaward testing.

(e) Multiple offers. Offerors are encouraged to submit multiple offers presenting alternative terms and conditions or commercial items for satisfying the requirements of this solicitation. Each offer submitted will be evaluated separately.

(f) Late submissions, modifications, revisions, and withdrawals of offers:

(1) Offerors are responsible for submitting offers, and any modifications, revisions, or withdrawals, so as to reach the Government office designated in the solicitation by the time specified in the solicitation. If no time is specified in the solicitation, the time for receipt is 4:30 p.m., local time, for the designated Government office on the date that offers or revisions are due.

(2)(i) Any offer, modification, revision, or withdrawal of an offer received at the Government office designated in the solicitation after the exact time specified for receipt of offers is "late" and will not be considered unless it is received before award is made, the Contracting Officer determines that accepting the late offer would not unduly delay the acquisition; and--

(A) If it was transmitted through an electronic commerce method authorized by the solicitation, it was received at the initial point of entry to the Government infrastructure not later than 5:00 p.m. one working day prior to the date specified for receipt of offers; or

(B) There is acceptable evidence to establish that it was received at the Government installation designated for receipt of offers and was under the Government's control prior to the time set for receipt of offers; or

(C) If this solicitation is a request for proposals, it was the only proposal received.

(ii) However, a late modification of an otherwise successful offer, that makes its terms more favorable to the Government, will be considered at any time it is received and may be accepted.

(3) Acceptable evidence to establish the time of receipt at the Government installation includes the time/date stamp of that installation on the offer wrapper, other documentary evidence of receipt maintained by the installation, or oral testimony or statements of Government personnel.

(4) If an emergency or unanticipated event interrupts normal Government processes so that offers cannot be received at the Government office designated for receipt of offers by the exact time specified in the solicitation, and urgent Government requirements preclude amendment of the solicitation or other notice of an extension of the closing date, the time specified for receipt of offers will be deemed to be extended to the same time of day specified in the solicitation on the first work day on which normal Government processes resume.

(5) Offers may be withdrawn by written notice received at any time before the exact time set for receipt of offers. Oral offers in response to oral solicitations may be withdrawn orally. If the solicitation authorizes facsimile offers, offers may be withdrawn via facsimile received at any time before the exact time set for receipt of offers, subject to the conditions specified in the solicitation concerning facsimile offers. An offer may be withdrawn in person by an offeror or its authorized representative if, before the exact time set for receipt of offers, the identity of the person requesting withdrawal is established and the person signs a receipt for the offer.

(g) Contract award (not applicable to Invitation for Bids). The Government intends to evaluate offers and award a contract without discussions with offerors. Therefore, the offeror's initial offer should contain the offeror's best terms from a price and technical standpoint. However, the Government reserves the right to conduct discussions if later determined by the Contracting Officer to be necessary. The Government may reject any or all offers if such

action is in the public interest; accept other than the lowest offer; and waive informalities and minor irregularities in offers received.

2. To provide guidance for resolution of routine, unique and unusual health care situations for International Military & Civilian Security Cooperation Training program students.
3. To assist DoD (DSCA and OSD/Health Affairs), Military Departments, Combatant Commands, Security Assistance Offices (SAOs), International Military Student Offices (IMSOs), Training Program Management Reviews (TPMRs), and supporting DSCA at same.

Ability to differentiate between and linkage of health care legislation, regulation and policy in accomplishment of technical requirements.

(iii) The deliverables to be produced in response to the requirements.

2. Monthly Report, as requested by Task Manager, addressing work assigned, accomplished, and any issues emphasizing Security Cooperation Training program processes and functional requirements.
3. Info copy on all written correspondence.
4. Soft copy of all prepared briefings.

2. Past Experiences. Describe a minimum of three (3) projects your firm has or is working on that address the kinds and types of requirements specifically called out in the SOW. Direct experience with the specific systems of the client identified in the SOW should be called out as well as experience with similar systems of other agencies.

- (a) Quality of Service
- (b) Timeliness of Performance
- (c) Business Practices/Customer Satisfaction

All sub factors for Past Performance will be of equal importance.

NOTE: *In the event that an Offeror has no Past Performance history, e.g., a new firm, this rating factor will be considered neutral and will neither increase an Offeror's overall rating nor decrease it.*

3. Price. The price proposal will be analyzed for reasonableness and completeness to determine the evaluated price to the Government.

B. Relative Order of Importance: Technical Approach is most important. Past performance is significantly less important than technical Approach. When combined, all non-priced factors are significantly more important than price. All subfactors are of equal importance.

SOURCE SELECTION PROCEDURES

A. Evaluation Criteria. The purpose of the evaluation criteria is to provide a sound factual basis for the Contracting Officer to select that offeror whose proposal offers the best value to the Government. The specific technical factors/sub factors are set forth in this SSP and will be included in the Addendum of 52.212-2 of the RFP. The relative importance of the evaluation criteria is described in Paragraph B above.

B. Related Definitions.

1. **Deficiency.** A material failure of a proposal to meet a Government or a combination of significant weaknesses in a proposal that increases the risk of unsuccessful contract performance to an unacceptable level. Examples of deficiencies include a statement by the offeror that it cannot or will not meet a requirement, an approach that clearly does not meet a requirement, or omission of data required to assess compliance with the requirement.
2. **Weakness.** A flaw in the proposal that increases the risk of unsuccessful contract performance. A "significant weakness" in the proposal is a flaw that appreciably increases the risk of unsuccessful contract performance.
3. **Advantage/Enhancement.** An advantage/enhancement describes some element of a response that notably enhances an aspect of the offeror's ability to perform the effort or that represents a significant benefit to the Government.

4. Clarifications. Limited exchanges, between the Government and offerors that may occur when award without discussions is contemplated. 2. Good: To receive this rating, proposed offer demonstrates a good understanding of the requirements. The Offeror has a high probability of success in completing the requirements. All factors/sub factors must have received a rating of a least Good/Medium Risk.
3. Satisfactory: To receive this rating, proposed offer demonstrates an acceptable understanding of the requirements. The Offeror has a moderate probability of success in completing the requirements. All factor/sub factors must have received a rating of at least Satisfactory/Medium Risk.
4. Unsatisfactory: To receive this rating, the proposed offer has received an Unsatisfactory/High Risk rating in one of the non-price factors/sub factors.
5. High Performance Risk: Likely to cause significant disruption to schedule, increased cost or degradation of performance. Risk may be unacceptable even with special contractor emphasis and close government monitoring.
6. Moderate Performance Risk: Can potentially cause some disruption of schedule, increased cost or degradation of performance. Special contractor emphasis and close Government monitoring will probably be able to overcome difficulties.
7. Low Performance Risk: Has little potential to cause disruption of schedule, increased cost or degradation of performance. Normal contractor effort and normal Government monitoring will probably be able to overcome difficulties.
8. Neutral: Insufficient relevant past performance information available.

2. Evaluation of Options. Except when determined not to be in the Government's best interest (FAR Part 52.212.2(b)), the Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. Evaluation of options will not obligate the Government to exercise the option(s).

3. Award on Initial proposals. The Contracting Officer retains the right to evaluate offers and make award without discussions with offerors. Therefore offerors are encouraged to insure that initial proposals contain the offeror's most favorable terms and reflect its best possible performance potential.

4. (a) Inspection/Acceptance. The Contractor shall only tender for acceptance those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. The Government must exercise its post-acceptance rights (1) within a reasonable time after the defect was discovered or should have been discovered; and (2) before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(b) Assignment. The Contractor or its assignee may assign its rights to receive payment due as a result of performance of this contract to a bank, trust company, or other financing institution, including any Federal lending agency in accordance with the Assignment of Claims Act (31 U.S.C. 3727). 252.219-7003 SMALL, SMALL DISADVANTAGED AND WOMEN-OWNED SMALL BUSINESS SUBCONTRACTING PLAN (DOD CONTRACTS) (APR. 1996)

This clause supplements the Federal Acquisition Regulation 52.219-9, Small, Small Disadvantaged and Women-Owned Small Business Subcontracting Plan, clause of this contract.

(a) *Definitions. Historically black colleges and universities*, as used in this clause, means institutions determined by the Secretary of Education to meet the requirements of 34 CFR 608.2. The term also means any nonprofit research institution that was an integral part of such a college or university before November 14, 1986.

Minority institutions, as used in this clause, means institutions meeting the requirements of section 1046(3) of the Higher Education Act of 1965 (20 U.S.C. 1135d-5(3)). The term also includes Hispanic-serving institutions as defined in section 316(b)(1) of such Act (20 U.S.C. 1059c(b)(1)).

(b) Except for company or division-wide commercial items subcontracting plans, the term *small disadvantaged business*, when used in the FAR 52.219-9 clause, includes historically black colleges and universities and minority institutions, in addition to small disadvantaged business concerns.

(c) Work under the contract or its subcontracts shall be credited toward meeting the small disadvantaged business concern goal required by paragraph (d) of the FAR 52.219-9 clause when:

(1) It is performed on Indian lands or in joint venture with an Indian tribe or a tribally-owned corporation, and

(2) It meets the requirements of 10 U.S.C. 2323a.

(d) Subcontracts awarded to workshops approved by the Committee for Purchase from People Who are Blind or Severely Disabled (41 U.S.C. 46-48), may be counted toward the Contractor's small business subcontracting goal.

(e) A mentor firm, under the Pilot Mentor-Protege Program established under Section 831 of Pub. L. 101-510, as amended, may count toward its small disadvantaged business goal, subcontracts awarded--

(f) The master plan approval referred to in paragraph (f) of the FAR 52.219-9 clause is approval by the Contractor's cognizant contract administration activity.

(g) In those subcontracting plans which specifically identify small, small disadvantaged, and women-owned small businesses, the Contractor shall notify the Administrative Contracting Officer of any substitutions of firms that are not small, small disadvantaged, or women-owned small businesses for the firms listed in the subcontracting plan. Notifications shall be in writing and shall occur within a reasonable period of time after award of the subcontract. Contractor-specified formats shall be acceptable.
