SUBJECT: Assignment of Code "T2" for United Nations Interim Mission in Kosovo, Security Assistance Management Manual (SAMM) E-Change 52 (DSCA Policy 06-27)

Effective immediately, SAMM Table C4.T2., Country and International Organization Codes and FMS eligibility, is updated to add code "T2" to track Kosovar students through the Training Management System and the Security Assistance Network Web. Kosovo is currently not eligible for Foreign Military Sales.
